The materials storage room is still in need of further care and organization to enable educators to easily access materials for programming. Previous comply by dates of August 23/21 and September 22/21. The gym equipment room appears unchanged since the last inspection visit (dust and debris collecting on the floor). This area requires cleaning. Previous comply by dates of August 23/21 and September 22/21.

Comments: Many games, materials and containers have been added to the outdoor play area. The grass/weeds were well maintained during today's inspection. There have been no accessories (such as pots, pans, spoons, muffin pans etc.) added to the mud kitchen to date. This area is a great opportunity for outdoor exploration, however, there are no accessories available for the children to use. Previous comply by dates of September 13/21 and September 22/21. When items/accessories like this are needed, efforts are to be made to obtain these items in a timely manner. Ordering materials online can cause delays, resulting in outstanding orders for compliance.

Educators need to be continuously adding to the children's environment as their interests evolve.</p> <p>Educators were observed speaking kindly to the children during today's inspection. The preschool children were enjoying a game of BINGO and some of the school aged children were observed building Lego houses and creating snowflakes. Children were observed indoors and outside today.</p> <p>Photos are to be sent to inspector once outstanding orders have been rectified. Unable to recommend for renewal at this time.</p>
