The child-to-staff ratio was respected during the inspection.</p> <p>The following elements were verified:</p> <ul style="list-style-type: none"> <li>- Transportation</li> <li>- Daily activities</li> <li>- Daily routine</li> <li>- Indoor play equipment and material</li> <li>- Washrooms</li> <li>- Storage space</li> <li>- Personal belongings</li> <li>- Diaper changing</li> </ul> <p>The Quality Assurance Monitor observed the children eating their morning breakfast. The children were observed playing in the indoor play area with Legos, spinning chairs and having an educator read them a book by their request. The Quality Assurance Monitor observed the educators implementing positive problem solving during a conflict between the children. The children were observed engaged in small circle time with the educators. The children had the chance to choose their own paper color and to cut with scissors working on their fine motor skills. Two classrooms had parents visiting for the day and engaging in the activities for the morning. The children on the second bus group were also observed arriving at the facility and having their breakfast. Positive interactions were observed between the educators and the children.</p>
