Operator may contact their fire inspector for advise on fire-ratings and acceptable types of décor.

Observed positive interactions between staff and children during the inspection. Discussed Designation requirement for staff portfolios with Operator. All educators working with children aged five years and under, not attending school, must develop and maintain a professional development portfolio to document their ongoing professional learning. Operator to provide guidance and support to staff to complete the learning opportunities, and staff are to report their completed hours of PL to Operator. Currently the Operator is filing all PL certificates in the staff files, she is to take copies for the files and give originals to the educators for their portfolios.
