Comments: Educator in the older preschool room does not have transitions planned to minimize wait times. Children were sitting at the tables waiting for longer than is reasonable to start "circle time". QA Monitor observed children fidgeting in chairs, picking on each other & jumping up from their chairs, staff were heard repeating sit down, don't touch your friend and constantly correcting the behaviours that were arising from the long wait. Transitions need to be planned to be shortened and go more smoothly. Operator and staff must revise the daily schedule to include transitions, staff must document the songs, rhymes or other activities that they will use for the daily transitions.

Comments: A child who was transitioned from one group to another was still recorded on the old attendance records and was not recorded on the attendance records for the new group. Attendance records must be accurate and reflect the children present.

Comments: An educator in the older preschool room was observed using one wet facecloth to wipe all of the children's hands after doing an art activity. Children cannot share the same cloth to wipe their hands as this transmits germs. Children's hands must be washed with soap and water in accordance with the Prevention and Control of Communicable Disease guidelines.
