Preschool children must be supervised at all times. A conversation was had with the Operator regarding this, who immediately put a plan in place in order to ensure that all children are supervised at all times. Deficiency is now compliant

Comments: A rug in the upstairs hallway is not properly secured to the floor, causing this to be a tripping hazard. Operator must ensure that the rug is secure or that it is removed, in order to ensure that safety of the children when walking in the hallway. A drawer is broken on a grey storage bin in a preschool classroom. Operator must ensure that this is repaired or removed in order to ensure the safety of the children.

During the Renewed Inspection, a shild fall outdoors. Operator filled out an insident log in order to opeure that								

During the Renewal Inspection, a child fell outdoors. Operator filled out an incident log in order to ensure that this information is documented. Operator must ensure that parent signs the incident log when picking up the child to confirm their awareness of the situation.

The mat used for diaper changes is starting to show signs of wear and tear. Operator must ensure that this is replaced as needed.

A discussion was had between the Inspector and the Operator about the licensing Regulation with regards to outdoor play. Inspector observed that each group played outside for at least one hour in every four hour period.

The license cannot be renewed until Operator provides Inspector with a copy of the new insurance policy that demonstrates general liability coverage as well as the motor vehicle insurance.
