The operator was able to print out the staff in questions first aid and cardiopulmonary certificate and insert it in the file. Deficiency is now compliant.

Comments: During the monitoring inspection, the Quality Assurance Monitor observed that 4-water bottles were not labelled with the child's name. All personal belonging must be labelled with the child's name.			

<p>General Comments</p> <p>The Quality Assurance Monitor was on site for a monitoring inspection. Ratio was respected during the visit.</p> <p>While on site the Quality Assurance Monitor verified</p> <ul style="list-style-type: none"> -indoor play area and the indoor play area materials and equipment -outdoor play area and the outdoor play area materials and equipment <p>During the monitoring inspection, the Quality Assurance Monitor was able to observe some of the preschool children nap and play indoor. The Quality Assurance Monitor also observed the afterschool children play outdoor with water and eat a snack.</p> <p>Discussion was had between the operator and Quality Assurance Monitor regarding staff member who plays both the role of educator and inclusion support worker. The Quality Assurance Monitor informed the operator that while it's OK for a staff member to play both the role of the educator and inclusion support worker, the staff member must always know what role they occupy. The Quality Assurance Monitor mentioned when arriving on site and gathering ratio, a staff member who was alone with 2 children napping voiced to the Quality Assurance Monitor being an inclusion support worker. The Quality Assurance Monitor mentioned to the operator that inclusion support worker doesn't count in the ratio and can't be left alone with children, the operator explained that the staff in question was playing the role of an educator at that exact moment because the child needing the support worker was sleeping. The Quality Assurance Monitor confirms that the staff can be an educator at times but must know their role to avoid confusion of ratio not being respected.</p>
