Comments: Group Logs: Reviewed group logs. These had not been completed properly. Discussed with operator. Ensure these are being completed daily and that temperatures are also being recorded for the children at mid day check. Garbage can lid within washroom where diaper changes are done was missing. This was fixed during the inspection. Thermometer: The thermometer on site is an infrared thermometer, which is currently being used on the children for mid day check. Non-contact thermometers are not allowed to be used on children under 12 years of age. Discontinue using immediately and use an armpit thermometer until the contact ear thermometer arrives (has been ordered).

Comments: Art materials within the preschool room were depleted at time of inspection. This area is in need of more variety (examples include but not limited to: white paper, colored paper, foam, pipe cleaners, textured pieces, more glue, stickers, popsicle sticks, cotton balls, paint).			
32(1) An operator of a licensed facility shall provide indoor play area materials and equipment that are (b) arranged on low, open shelves and accessible to the children receiving services at the licensed facility,	32(1)(b)	Jul 16, 2020	
Comments: There were lots of art supplies available within the facility, but they were not accessible to the children within the preschool room. Ensure this area is replenished often with different materials to engage the children and promote creativity. These materials should be accessible at all times.			

General Comments
Monitoring Inspection COVID-19 Recovery Phase. Screening process was observed upon arrival of some children. The children were instructed to wash hands upon entering. Facility has a binder on site containing COVID-19 related documents including Appendix E signed by parents. The educators were engaged with the children and spoke to them in a respectful, nurturing manner. Discussed having more board books available on the preschool book shelf and introducing an "all done" bin

that can be used once the book has been handled so that proper sanitizing can be done.  
The children within the preschool room have recently turned the dramatic play area into an ice cream stand and have been really enjoying this.  
Documentation of the children's learning (in the form of mobiles, photos, books created by the children, and collages) were posted throughout the facility and interests were apparent within both rooms.  
Cleaning procedures were discussed during the inspection. Also discussed the possibility of dividing rooms to accommodate a second group of children, should enrollment increase.  
Operator reports that a contact ear thermometer has been ordered, but has not yet arrived. Use an armpit thermometer for mid day checks until this is received.
