| Completed renewal inspection today. Children were observed within their indoor and outdoor environment. The indoor environment was set up with inviting materials and displays that incorporated science, art, culture and music for the children to explore. There were various forms of documentation displayed within the older preschool/ school aged room demonstrating the children's current and recent interests. Ensure dates are recorded on documentation. Educators value the children's art and contributions by leaving work that is unfinished for the children to finish at a later time. The children's creative art work is also displayed throughout the environment for them to revisit. Outdoors, the school aged children were observed to be active and engaged in building with items from nature and were eager to share their creations in the wooded path areas. The children appear to value their outdoor time and were observed working together in groups as well as individually. Ensure that if children are to use any

type of rope or string within the path area (for fort building, etc.) that this is under direct supervision. Educators within the younger preschool class also spoke of the children's current and ongoing interests such as learning about themselves, dressing up in costumes and outer space. Recently, the children have been exploring the topic surrounding "every child matters."

The children were observed eating lunch and during rest time. The children appeared comfortable with their daily routine.

Recommending that operator add additional storage totes with lids for outdoor toys/mud kitchen supplies to preserve outdoor equipment (inside the fenced in area, as well as within the school aged outdoor play area). Ensure children have access to bins/storage within the school age play area to clean up and store their materials and equipment at the end of the day.
