Comments: Children did not wash hands prior to eating snack. Advised educator and site lead that children must wash hands upon arrival afterschool, and then later wash their hands again prior to eating snack.  Facility cleaning schedule was also discussed and recommended that the site lead ensure the cleaning checklist has been completed as there was remnants of crumbs and debris within some of the centers within one of the groups space prior to the children arriving. This time, prior to the children's arrival should be used for cleaning, and purposefully planning so that the environment is ready for the children's arrival each day.

Comments: Painting and wall repairs have not been completed as of yet. Administrator advised that YMCA staff will be completing the work and not the town of Quispamsis. Please advise of scheduled date for repairs/fresh paint to be completed.			

<p><b>General Comments</b></p> <p>Completed another follow up to renewal inspection today. Outstanding orders for compliance remain. Please review hand washing policies with all staff . Recommending that a staff member supervises children as they wash their hands to ensure proper hand washing occurs. Discussed the importance of purposeful planning and setting up the environment based on the children's interests with administrator. Some educators require additional support designing their environment to reflect the children's current interests (previously noted in past inspections on Oct.13/20 and Oct.29/20).</p>
