<p>Monitoring Inspection:</p> <p>Children and educators observed engaged in a variety of activities this afternoon including card and board games, a paper plane challenge, an arcade game challenge, outdoor play, ball hockey, and open-ended art. Educators observed engaging in meaningful conversations with children.</p> <p>Seniors:</p> <p>Purposeful planning is evident through invitations, documentation added to the environment and on planning sheet. Materials have been added to the environment that support the children's current interests (games, work-out challenges, hockey and paper planes).</p> <p>QA Monitor discussed use of playground with staff during winter months. Currently the surfacing is not frozen however, once the surface is frozen/ice covered the playground must not be used by children.</p> <p>Hand washing routines observed at arrival, after outdoor play and before snack. Daily attendance forms observed to be accurate and maintained. Cheese and crackers with fresh vegetables were served for snack.</p>
