Educators stated that they were waiting for their weekly attendance record sheet to be dropped off to their room. Attendance records are: mandatory; recorded using the attendance form provided by the department (Appendix 10); only completed by staff members; confidential and not posted or viewed by parents; completed each time a child arrives and leaves; accurate and reflect all children present at any given time; complete, showing all absences and detailing the reason; easily accessible to all staff members; and taken out of the facility whenever children leave the building. Attendance records to be in each room, ready to be used, before children arrive. Administrator brought attendance record to classroom during today's monitoring. Attendance record was completed while QAM was in classroom. Deficiency is now compliant.

A Monitoring Inspection was completed this morning. Infants were observed inside. Infant Room - Infants were finishing up their snacks at QAM's arrival. Diaper changing procedures were observed. Infants were observed playing with balls, looking at books, singing Happy Birthday, and clapping their hands. Educators were engaged

with the Infants - giving gentle reminders, using positive language while interacting with the infants, sitting with the infants on their level, conversing with the infants, and taking part in play. Two's Room - Children were observed gathered on a mat, in the reading area, listening to a read aloud Robert Munch book. After story time, children were observed during free play. A group of children were observed playing in the dramatic play area, grocery shopping and preparing food. Others were observed playing with toy vehicles. Three's Room – QAM observed the classroom environment, while the children played in the gym. During the classroom observation, it was evident that the children's present interests included Dinosaurs and Volcanos. Several forms of documentation were observed - dinosaur and volcano word webs, painting with dinosaurs, and a T-Rex footprint, with children's guesses on how many of their shoes could fit inside. Children were also observed playing in the gym. Children were observed playing with ribbons, balls, and running. Four's Room - Children were observed during free play. A group of children were observed sitting at a table, mark making. Children were also observed playing with Lego, playing with Barbies, and creating music.
