A renewal inspection occurred today. The children were observed in both indoor and outdoor environments. Each environment provided materials displayed at children's level that can be independently accessed. Open-

ended materials were in each environment. Open-ended materials provide multiple choices, solutions and possibilities for exploration and investigation.

Fours room had labelled materials to help children with maintenance and care. Educators were observed playing a fun game of 'Ispy' for transition into morning snack. Dramatic play area had natural, familiar, real-life materials that represent children's home environments.

Threes room had learning stories reflective of children's previous experiences that give children an opportunity to revisit their thinking and creations.

Twos room had displayed purposeful planning that was reflective of children's emerging interest. Dramatic play area was set up with a homemade ice cream shop that was repurposed for children's use.

Infants room had a family tree displayed on wall that reflected each child's familiar home environment. The reading area was inviting and open ended for the children to explore. Invitations were set up in each area for the children to investigate.
