General Comments

Name of operator

A renewal inspection occurred today.

Children were observed both in the indoor and outdoor environment. Educators engaged with the children and were observed down at their level. Quesadillas, potato wedges, vegetables, and fruit were provided for lunch. Educators were observed sitting with the children, modeling positive eating habits. The indoor environments were set up in advance of the children returning from playing outside. Documentation was current and reflects the children's ongoing learning and interests.

Infant room educators were observed working cohesively as a team. As children finished morning snack one educator washed the child and cleaned, one educator was changing diapers and washing hands, and one educator was getting the infants in their snowsuits to go outside. The transitions between snack, diaper changing, and outside ran smoothly.

Two's room educator was observed sitting with the children in the reading area. The children were listening to an audio book 'Cookies for Santa' as the educator turned the pages and asked the children questions about the story. When the story was done, the educator played I Spy with the children, calling out different colors of their clothing to wash their hands and get ready for lunch.

General Comments

Three's room were observed during quite time. Children who did not nap were brought down to the running room where educators set up various learning interest centers for the children to engage in play quietly. This allowed for the children to still have down time but still have the freedom to play and move around while respecting their friends who were napping in the classroom.

Four's room educator invited children to share their story books they brought in from home. The educator read their stories and asked questions to the children as they were reading. Children shared with their educator what type of Christmas tree they have at their home.

Hand washing and diaper changing observed.

All staff files and random review of children's file completed.

Discussed the following with the administrators:

- 1. Menu substitutions are documented and maintained on file for at least one year.
- 2. Wooden car outside needs to be fixed. Administrators shared plan to have the car repaired in the Spring. QAM to follow up in the Spring.
- 3. Facility is currently in the process of painting each room and only has one room left to do. QAM to follow up on next monitoring inspection.

Facility is recommended for licensing.
