Comments: When licensing staff arrived in the javex and water solution was accessible to children on one of the tables in the classroom.

Comments: At nap time, in the infant room, there were 4 infants awake and only one staff member supervising the children while one child was sleeping in the nap room unsupervised. This does not meet child/staff ratio regulation.

Please ensure Covid-19 questions are asked before anyone enters the centre.</p> <p>It was also noted on two sperate occasions the javex and water solution was left on a classroom table where</p>

children could access. Please ensure that this solution is kept out of children's reach at all times.

When reviewing the children's files it was noted that a medical practitioner/doctor is not named on a number the child profiles. Please ensure these profiles are updated.

When reviewing the first aid checklists it was noted that not all items on the checklist are present in the first aid kit. Please ensure that the first aid kit is equipped with the contents prescribed by New Brunswick Regulation 2004-130 under the Occupational Health and Safety Act..

Fire Drills and evacuation drills have been conducted however, fire extinguishers have not been inspected since 2019. Please ensure the fire extinguishers are inspected on a yearly basis as per regulation 24 (1) (k) of the Early Childhood Services Act where it states that smoke alarm, smoke detectors and fire extinguisher inspection and maintenance records shall be maintained on the premise of a licensed facility.

Child/staff ratio needs to be maintained in the infant room during lunch breaks if the children are still awake.
