Comments: The wind was causing the door from an adjacent storage cabinet to open (no latch on door) and block the gate from opening. The gate must open and close properly to ensure easy entry and exit from outdoor play area.

Now that spring is here, the director and staff have a plan to clean up the outdoor play area and make it more inviting for children. They have set a goal in their QIP to extend the classroom into the outdoor play area.</p> <p>One group of preschool children played in free play, while another group participated in a planned activity.
