General Comments

Upon Licensing staff arrival, there were no children present at the centre. The children and their Educators were at the Take It Outside location and I joined them later on during my inspection.

During my time at the centre, an Educator provided me a tour and discussed future plans and location changes. Child and staff files were verified, and all required documentation was present. The parent board was organized and required information was visible.

The main room was bright, clean and organized. Play material such as blocks, a sensory table with dried corn, art supplies, books, a play kitchen with supplies, dinosaurs, and wooden train tracks were in good condition. The space was set up in centres and there were large lockers with mirrors containing additional art supplies along the back wall. Elements of nature were incorporated throughout the space and drums were placed on a shelf for the children to use. There was a grandmother drum in the centre of the room and felt coverings were accessible to be put over the drums at the end of each day. The Educator informed me that the material from the main room and storage cubbies for the children's belongings will be used at the new location when complete.

When I arrived at the Take It Outside location, I was welcomed by an Educator. The children were sitting together having a snack. The snack of the day was a granola bar, grapes, and crackers with hummus. The Educators were observed to be sitting with the children and were actively engaged. Positive words of encouragement and praise were heard such as "great job!" "you are amazing!" and "great words buddy!". The children were encouraged to drink water throughout the afternoon by giving cheers to each other with their water bottles. The children were happy and enjoyed clinking their water bottles together before taking a drink.

The area for Take It Outside has a fire pit area with logs for seating and clear boundaries marked with ribbon that the children and Educators have set together. During my inspection, a child had a little fall. An Educator quickly provided snuggles, kind words, and hugs, ensuring the child was not hurt. After the snacks were all cleaned up and garbage put away, the children and Educators carved pumpkins together at the picnic table. The children were excited to scoop out the seeds and feel the inside of the pumpkin.
