General Comments
<p>Children engaged in many forms of play at time of visit. Most were returning from outdoors. Proper screening protocols are occurring and documentation to meet Covid-19 Guidelines is evident.</p> <p>Educators speak to children at their level and take interest in what they are doing. Observed one of the educators giving children a better choice to change unwanted behavior.</p> <p>Please ensure that birth dates and registration dates are correct on child profiles.</p> <p>Operator stated that they have not had to use potential illness forms as the children and staff have been healthy. In the event that you do have a communicable outbreak, please ensure that all management of illnesses forms are used appropriately. Potential illness and return after exclusion forms are part of the children's file. The Notice to Inform Parent(s) of a communicable disease would be posted on the entrance door and kept on file for a year.</p> <p>It was also stated that they have not had any major or minor incidents to report or keep a log of. Operator does have an incident journal to report non reportable incidents.</p> <p>Please ensure that diaper changing procedures are always being followed. During the washroom inspection the Licensing staff took note of a bag of dirty diapers that were sitting by the diaper changing station in a plastic bag. Licensing staff spoke to Operator who then spoke to educator and educator admitted that they forgot and stated that usually do not do this. Diapers were disposed of in a garbage can that sits in the school age area.</p>

General Comments

After speaking with the operator, they immediately placed a smaller garbage in the washroom for the disposal of diapers.
