Comments: Attendance records were not present in the forest or within the outdoor play area. Forest school staff were unsure of the number of children in attendance when questioned by licensing staff. Attendance records on forms provided by the Minister were in the office at Lisa's Playhouse. When educators complete the attendance records for their individual groups, they are aware of the number of children in attendance at any given point throughout the day. As per section 6.2.5 of the manual: Attendance records are: - Accurate and reflect all children present at any given time - Easily accessible to all staff members; and - Taken out of the facility whenever children leave the building.			

<p>General Comments</p> <p>Monitoring inspection opened during visit to follow-up on previous non-compliance and a request for change.</p> <p>Children were observed indoors and outdoors during inspection.</p> <p>As was discussed with administrator on-site, the maximum number of children in the forest school and using the forest school buildings cannot exceed the measured floor space for the indoor play area. Each forest school building measures for 9 children. As per the license issued to the facility, the number of children cannot exceed 42 in Lisa's Playhouse and 18 in the forest school.</p> <p>Job description in one staff file was not accurate for role. Job description must be amended to reflect the actual role and responsibilities of staff.</p>
