General Comments

A renewal Inspection occurred on today.

Children were observed in various areas of play both inside and outside. Each environment provided materials displayed at children's level that can be independently accessed. Open-ended materials were in each environment. Open-ended materials provide multiple choices, solutions and possibilities for exploration and investigation. The educators were observed engaged in meaningful conversations as well as playing with the children.

General Comments

Hummingbirds room- Documentation of Children's ongoing learning evident. Educators ensure evidence of children's home environments are displayed with care and respect with pictures of children and their families displayed at the infants' level.

Owlets room- Currently learning about Remembrance Day. Art activities reflect this in the indoor environment. Educators observed sitting with the children during lunch time. Small groups were observed for diaper changing. Educators sang songs with the children as they waited for all children to be ready to have lunch.

Sparrows Room- Sign language displayed around the classroom shows an inclusive environment. Current documentation for Remembrance Day displayed. Educators observed reading "I Can, Can You?" to the children during lunch time. Educator asked open-ended questions as she read the story.

Robins room- Invitations for play such as the Red Bird was set up in the sensory table. Homemade story felt board of 'Goldilocks and the Three Bears' set up on a table for children to experience the story in a different way. Art area was set up with a wide range of Art materials for the children to explore.

Blue Jays and Chickadees- The indoor environments as well as the outdoor were set up with a wide range of open-ended materials for the children to explore. Documentation of current learning is evident in both the indoor and outdoor environment. Children were observed writing thank you cards to soldiers in honor of Reembrace Day.

All staff files and random review of children's file completed.

Diaper changing, hand washing, meal and nap time observed.

Incident logs, fire drills and maintenance checks reviewed.
