Monitoring Inspection:

The Administrator shared with licensing staff that it was Apple Day. The Administrator shared that one of the children had requested an Apple Day where the entire day would include apples. During the morning the children were observed making food for the hornets by places apples into a zip lock bag and then smashing the apples with a wooden mallet. The children were also observed painting apples, stamping with apples, and eating apples.

The classroom environments were set up with a wide range of materials. Documentation and pictures of the children were evident around the classrooms.

Licensing staff discussed art materials for the infant room and the Administrator shared that they are working with their curriculum specialist and have included this in their Quality Improvement Plan.
