Comments: Diapers, wipes and creams were not labelled. Operator placed each item in separate pocket of change table and labelled each pocket. Deficiency is now compliant.			

**General Comments**

QAM discussed with Operator that children enter and exit the home through the garage, and have cubbies in the garage in the warmer months, so it is important to ensure the safety of the garage as well. QAM noted tools and various products to be addressed by Operator.

In the large washroom there were packaged snacks stored in the cupboards. Operator assured QAM there is no food preparation happening in the washroom. QAM advised Operator to check with Public Health regarding their view on this.

QAM observed children engaged in free play, play dough, wobble board, and kitchen play. QAM observed Operator reading stories to children, and offering positive child guidance, getting down to children's level and participating in floor play.

QAM and Operator discussed the entrance of an infant of six months to the home in the coming months, and the requirements for the rest area and length of infant sleep, as well as walking to the bus stop with infant.
