Visit to facility for the annual inspection visit (during COVID-19 period). Ratio was respected during visit and

facility followed COVID-19 regulations.

A few staff were missing copies of their first aid certificate on file, these were retrieved and added to their file during the time of inspection.

Discussion with operator regarding climbing dome in outdoor play space. I recommended that the operator check the play structure manual in order to verify how much protective surfacing is required under the structure, once this is confirmed more protective surfacing must be added. I also recommended she check with her insurance to ensure proper coverage for this structure.

Recommended that children's files be revised to ensure that all children's files are complete with the following information – medical practitioners' complete details, full addresses of emergency contacts and people who have permission to pick up children. One child missing signed consent forms, these need to be filled by parent.

New staff are presently enrolled in 30hr/60hr course online. Ensure that proof is added to file once course is completed.

Observations during inspection – 2-year old's, 3,4,5-year old's were outside playing during visit. Infants were participating in a fish painting activity.

The facility is presently awaiting public health's inspection.
