Comments: A few staff members do not have a valid first aid course. Operator must ensure staff are registered for a course and send proof of registration to the inspector.

Comments: Several new staff members are enrolled in the 90hr course. Certificates must be added when the course is completed and the inspector should be notified.

Comments: The fence between infant play area and preschool area is not secured to the ground and sharp edges are sticking out, this must be repaired.

Comments: Milk bottles must be stored in the fridge at all times.

Comments: Bottle in the fridge without cover or name. All bottle needs to be covered and labelled.			

General Comments

Visit to the facility for the annual inspection.
Ratio was respected during the visit.

Reminder to operator to ensure all lunch boxes have their names on them and ice packs in them if they are not placed in the fridge.

Several staff members were missing the signed declaration in their file, the operator had staff members complete this while the inspection took place. They are not compliant.

Discussion with operator regarding spacing between cribs and cots, 46cm must be between each crib, cot or mat.

Cleaning products were a shelf in downstairs bathroom on a shelf. Although they were out of the children's reach, these must be locked under key when not being used. These were moved during the inspection.

Recommending to operator that all children's profiles be reviewed to ensure that addresses are complete.
