Children are always supervised when using the washroom. One potty chair and or training seat is provided. Steps and platforms are provided to allow children to reach toilets or sinks.</li> <li>- The facility has a quality improvement plan in place. The educators have completed professional development hours.</li> <li>- Observations: Upon my arrival all children were playing outside.</li> <li>Infants: diaper changing, hand washing, lunch, and naptime.</li> <li>2-year-olds: lunch, diaper changing, handwashing and naptime.</li> <li>3-year-olds: lunch and naptime</li> <li>- Discussion with the operator concerning the educators' qualifications.
