<ul style="list-style-type: none"> - Visit completed in the morning at the facility for a monitoring inspection. - Ratio was respected during the visit. - Positive child guidance was witnessed during the visit. Educators were observed engaged with the children at their level providing support and having conversations. - The personal files contain all required documentation. Administrator and educators have completed the Introduction to ECE course. 12 staff files were verified during the visit. - In all rooms, evidence of purposeful planning based on children's interest and learning, webbing, invitation, photos and learning stories were posted. - Observations: Infant room: During the visit free play, diaper changing, lunch and naptime were observed. 2-year-old room: During the visit naptime was observed. The child that was not sleeping was drawing pictures and looking at books with the educator. 3-year-old room: Naptime was observed. The two children who don't nap was discussing with the educator, drawing pictures, and

looking at books.

- Discussion with the co-director on staff members files. The educator who has not completed her CPR training may not open, close the facility or be alone with a group of children. Discussion with the educators on documentation and planification. The educators presented their documentation to me. Discussion with the operator and co- director on naptime. The minimum space between rest equipment must be at least 46 centimetres.
