<ul style="list-style-type: none"> <li>- Visit completed at the facility in the afternoon for a monitoring inspection.</li> <li>- During the visit, ratio was respected.</li> <li>- Positive child guidance was witnessed during the visit. Educator observed engaged with children at their level providing support and having conversations.</li> <li>- The outdoor play area is maintained safe. The operator is presently rethinking the outside space. Material will be added in the next few days. There is no stationary equipment in the outdoor play area.</li> <li>- Outdoor play time occurs in the morning and in the afternoon. Meals and snacks are served at the recognized hours and a daily rest period meets the children's needs.</li> <li>- During my visit, cleaning products were not locked. Immediate action was taken, the products are now locked.</li> <li>- Daily incident log is maintained, parents are advised and sign the daily log.</li> <li>- Observations:</li> </ul> <p>Infant room: Naptime and free play was witnessed during the visit. The educator was talking and playing with the infant who was not napping.</p> <p>2-year-old room: During the visit, parent arrival and naptime was witnessed.</p> <p>3-year-old room: During the visit the children were creating art and naptime was also witnessed.</p> <ul style="list-style-type: none"> <li>- Discussion with the educators on toxic products and the outdoor play area. There is a plan in effect to improve the outdoor area. More material should be added to the outdoor play area.</li> </ul>
