General Comments
- Visit completed at the establishment in the morning for a monitoring inspection. - During the visit ratio was respected. Infants are not mixed with the preschool groups after 8:30 a.m. or before 4:30 p.m.

General Comments

- The facility has a designated rest area. The minimum space between rest equipment is at least 46 centimetres. All nap equipment is washable and non-absorbent. The children (15-24 months) sleep on a cot. The rest area for children under 15 months is separate from the play space. The infants 0-15 months sleep in a crib.
- Posted at the entrance of the facility are the following documents. The license, inspection reports, order for compliance, daily routine, evacuation procedures, name of the administrator, name and telephone number of the QA Monitor and the inspector, life-threatening allergies and when it applies a notice to inform parents of the existence of a communicable disease.
- Administrative records are maintained on-site.
- Personal belongings are labelled with the child's name. Easily accessible and stored separately for each child.
- Toxic products, chemical products and cleaning supplies are locked in the upstairs washroom and inaccessible to children.
- Observations:
Infants:
During the visit, parent arrival, diaper changing, nap time, free play and outdoor play were observed.
- 2-3-year-olds:
Upon my arrival, the children were gone in the community on a nature walk. The children arrived from their walk and played in the outdoor play area.
- Discussion with the director on the monthly emergency evacuation and fire drill and staff files. The emergency evacuation and fire drills must be completed each month. 1 staff member was missing the following documents in the file – a copy of a criminal record check/vulnerable sector, description of duties and responsibilities, signed statement regarding obligations under the Act and licensing regulation and a copy of a valid first aid certificate. All required documents were added to the file during the visit.
