<p><b>General Comments</b></p> <p>Licensing staff arrived at the centre at 8:30am.</p> <p>Child-to-staff ratio was within regulation of the Early Childhood Services Act.</p> <p>In the 4/5 classroom the children were engaging in centres and free play within the invitations of play created for the children. The children were able to move freely between each centre if they so desired. I observed two children playing in the quiet centre. An educator was also reading a story to the children in the quiet centre.</p> <p>Another group of children in the 4/5 classroom were playing cards with the educators and lots of giggles were heard. The children were peeking at the cards thinking the educator did not know and getting a lot of enjoyment with this. The educator interacted at the children's level and was very interactive. Well done!</p> <p>The children transitioned to snack time very well! The educators offered the children a choice at which table they wanted to eat their snack at. The educators and children said "grace" before eating their snack and then began to eat.</p> <p>After snack, the children went to sit on the carpet and practiced reciting "Oh Canada." After reciting the anthem the children went to wash up and play at the centres that the educators set up. The children could choose which centre they wanted to play at. There was a rice centre, a mark making centre, a building centre, water play centre as well as a sand centre. The children enjoyed playing with these centres and were free to explore other centres as well.</p> <p>Another child was observed putting a puzzle together. Positive child guidance was observed throughout the morning during the follow-up inspection. The educators in the 4/5 classroom were very good at redirecting any</p>
