Comments: During the follow-up inspection, the inspector observed that a newly hired employee has an Early Childhood Certificate from a college that is not signatory with Colleges and Institutes Canada. Comments: During the follow-up inspection the ground is frozen and play structures are blocked off therefore, the park assessment will be conducted in the spring with a member of the licensing team. The use of the outdoor play structures is not recommended as the ground is frozen and does not provide protective surfacing. Deficiency is now compliant.
