*An annual Inspection was performed today. This unique ASP carries a physical literacy component and the centre just recently relocated to this newly renovated space.

*During my visit the operator developed a 2 page document that addresses all the above items required for summer camp registration. This information is available during the school year but he needs to be requesting same information for summer camp. Thank you. That will definitely make it easier for parents to complete.

*The Operator completed the renewal application and provided the renewal fee during my visit. Thank You! *Staff signed statement is in the staff file, but it needs to be updated to reflect the changes to legislation. Refer to section 6.4 in the operator manual to develop a new form

*The Operator is in the process of building an outdoor fenced in playarea/gym with rubber matting. Lots of active play opportunities will then be available on a daily basis, however this facility provides transportation and takes children off site to a number of locations in Fredericton. Today children were off to Liverpool school to play outdoor hockey in the AM and off to UNB Woodlot for Capture the Flag in the PM. You will be required to keep a maintenance checklist depending on the type of equipment stored in the outdoor area including a storage of smaller types of equipment. You can develop your own list that will be applicable to your programming needs. *Child and staff records were reviewed during my visit.

* No Incidents to report but refer to section 6.6.1 in the Operator manual that will help in development an incident log book for non reportable incidents and to ensure parents sign off on the same day so they are aware. Use appendix 15 if you ever have a reportable incident. That form would need to completed, parent receive a copy, one stored in child file and one to go to me.

The operator advised sometimes they take children to public pools with a life guard. Please ensure the ratio is 1 to 8 for school age children
