General Comments

**Follow up to inspection requirements were addressed via email on August 29, 2019 whereby the operator addressed additional parental consents and a new registration form for summer camps. He also updated the child profile and parental consents during the school year and posted the inspection report.

**A continuation of licence letter was issued to the operator the end of August.

** During my visit, the new outdoor area was measured and approved by our department. The netting that will be added to the top of the fenced in area will keep balls from leaving the space, and it will also be useful for an ample shade structure. PH must also inspect the outdoor area to ensure it meets their regulations. At the time of relocating, the operator did not have an outdoor play area, though it was not a requirement for school age programs. The operator has plans to develop another outdoor area for children to sit , relax, and enjoy eating snacks and lunches and other play opportunities that will be nestled inside the trees that surround the property. Each side of the fenced enclosure measures for 25 child spaces, totaling 50. Please see attached comment sheet with measurements.

All compliances have been met for continued licensing. A renewal license will be issued once the department receives an updated PH report.
