General Comments

Name of operator

Licensing Staff arrived at the facility to perform a Monitoring Inspection. The children had just arrived at the facility and were sitting down for lunch. Several children are involved in extracurricular activities at school; therefore, the group is quite small today. As the children finished lunch, they were observed playing games such as chess, card games and Connect 4. Once the group had finished lunch, hand washing was observed before the children made their way outside. Water bottles and hats were brought out.

Once outside, the children lined up by the building to go over rules for the outdoor space. Educators had set out several orange pylons in the parking lot as reminder to vehicles that children are playing in the area. In the wooded section, orange spray paint was seen on the trees as a visual reminder for the children of where the boundary is. Outside there is a large storage container with supplies such as hockey sticks, helmets, basketballs, chalk, footballs and badminton rackets. Children were seen playing basketball, hockey and exploring the woods.

During the visit all Educators were engaged with the children. Educators were seen playing Capture the flag and basketball with the group. Positive child guidance was seen, and Educators made sure all children felt included in the games. The facility is extremely clean and organized. Childrens belongings are labelled, and the cubby area is tidy.
