A Monitoring Inspection was completed this morning. Children were observed inside. Upon arrival, children were observed sitting at two tables, finishing up their snacks. After snack, children were observed washing their hands, before play. The room was set up with several purposely planned learning activities and well-defined centers - holiday sensory bin, arts and crafts table, an easel with paint, paint brushes, and paper; a cozy reading corner which included a Christmas tree and homemade fireplace, a dramatic play area, and an area for building. Several forms of documentation were observed throughout the facility - learning stories, children's artwork, word webs, and ongoing science experiments - watching a pumpkin decompose, with written recordings of children's thoughts and comments. Positive child guidance techniques were observed - educators offering choices, using
