On the day of my visit, children enjoyed outside time as soon as they arrived at the centre. Some children arrived by the Preschool Centre Bus and others walked over with an educator. Educators use pylons and rope to create a boundary for the children to play on the pavement. Children enjoyed riding plasma cars and playing basketball.

When walking to get children from school, please take a first aid kit with you in case of emergency. This could be in a backpack along with the cellphone and clipboard with attendance and emergency contacts for children.

I noticed dishwasher tabs and cleaner underneath the sink in the kitchen. These must be kept in the other cupboards that are locked or a lock added to that cupboard.

General Comments

The facility is set up so that each room has a different set of resources and materials. The main area is set up as the "diner" and has tables and a sign that says "Grandame Diner" along with baskets with fruit and crackers. Each table has a table cloth (Halloween themed at the moment) and there is a table with dishes and toasters. This is an interesting set up that is unique and makes it very inviting.

There is an art room where children have created their own art room rules. There are other rooms such as a game room and each room is organized and has a variety of materials for the children to access.

I observed positive child guidance and educators were engaged with the children. During snack, an educator did Halloween Trivia with the children. The children really enjoyed this! Children also had the opportunity to share what they were going to do on the weekend.

All covid protocols are being implemented and followed. Children sanitized and washed hands throughout my visit at all required times.
