Comments: During inspection, a conversation occurred with the Administrator concerning the completion of Professional Learning hours. Professional Learning hours are to be worked on throughout the licensing year and 10 Professional Learning hours are to be completed by required Educators by renewal. Resources have been provided, and a plan has been put in place for required Educators to complete 10 Professional Learning hours by the end of August 2025. General Comments							
Upon Licensing staff arrival for the renewal inspection, the children were having morning snack.							
Classrooms were organized, tidy, bright and inviting. Material was organized in easily accessible labelled bins or on shelves. Elements of nature were incorporated throughout each space as well as family photos and							

children's artwork. Children were observed colouring, making diamond art, and playing with colourful blocks. Music was playing in the 3-year-old classroom, and the Educator and children were observed signing.

Later in the morning, Educators from each classroom prepared to go outdoors. Water bottles were filled up, sunscreen was applied to the children, and the First Aid backpacks were taken along. The outdoor play space is fully fenced and included a large umbrella and green sunshade on the inclusive playground. It is recommended that additional shade be added to the mud kitchen area as well as along the side of the building where the children dig in the sand. Before returning indoors, headcounts were observed as the children lined up inside the fence.

Once inside, the children were observed washing their hands before lunch. There is evidence of daily routine as transition times were smooth. During lunch, the children sat together at the table and Educators were actively engaged in conversation and were observed assisting with lunch packages. Once finished eating, the tables were cleaned, and the floors were swept. The transition to nap for the 3-year-old children was smooth with calm music playing and the curtains drawn. The 4-year-old and school age children were observed playing quietly with tabletop activities such as bristle blocks, colouring and magnet tiles. Throughout the inspection, Educators were observed engaging with the children offering positive words of encouragement and affirmation.

During inspection, child and staff files were verified. Monthly fire drills and outdoor checks are being completed and logged. Only positive child guidance was observed, and gentle reminders were heard by Educators on using indoor voices, respecting friends and being kind.
