Comments: During the Inspection, Inspector observed that the monthly review and maintenance plan for the stationary equipment was not documented for the month of June. 39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies; Comments: During the Inspection, Inspector found toxic products located in an unlocked storage closet. All toxic products must be placed under lock and key. Administrator placed these under lock and key immediately. Deficiency is now compliant	39(2)(a)	Jul 14, 2022	Jul 14, 2022
48(2) An operator of a licensed facility may supply food to a child receiving services at the licensed facility that a parent or guardian of the child brings from the child's home if the food is labelled with the child's name and refrigerated, as required. Comments: Inspector observed that not all water bottles and lunch boxes were labelled with the child's name.
