New members have not been added to the list, and individuals who are no longer serving on the board are still listed. The administrator immediately updated the list. Deficiency is now compliant

Comments: During the renewal inspection, a bottle of Febreze, deodorant, and an odor spray were found in the bathroom. These items are considered toxic, chemical, or cleaning products and must be stored in a manner that is locked and inaccessible to children. The administrator immediately took corrective action by locking the products in the locked storage space. Deficiency is now compliant

<p>The Quality Assurance Monitor was on site to conduct the renewal inspection. Child-to-staff ratios were respected at the time of the visit.</p> <p>During the inspection, preschool children were observed engaging in outdoor play and having lunch. Upon arrival of the school-aged children, children returned outside to play in the wooden area.</p> <p>The Quality Assurance Monitor held a discussion with the administrator regarding the importance of maintaining up-to-date child profiles. The administrator informed the Quality Assurance Monitor that a child who previously required an Epipen for allergies no longer needs it. The Quality Assurance Monitor reminded the administrator that any changes to a child's medical or allergy information must be made by the parent or guardian in the child's profile.</p>
