<p><b>General Comments</b></p> <ul style="list-style-type: none"> <li>•Visit to the facility in the afternoon to complete the annual inspection.</li> <li>•Ratio was respected during the visit.</li> </ul> <p>Observations:</p> <ul style="list-style-type: none"> <li>•Upon our arrival the afterschool children were eating their snack. One group of after schooler's were working on a group project, some children were drawing/coloring, others were playing hairdresser and some children were creating with Lego.</li> <li>•The 4-year-old group was having snack upon our arrival. The educator was singing with the children. Children were into volcano's and dinosaurs, educator observed engaged with children at their level providing support and having conversations.</li> </ul> <p>Discussion with administrator:</p> <ul style="list-style-type: none"> <li>•We recommend the centre contact their early learning consultant to increase the use of the curriculum in their daily routines. Example: webbing, learning stories, documentation of ongoing projects.</li> <li>•More material should be added to make zones more inviting and to expand the children's creative play.</li> <li>•The Little tikes play structure in the 3-4-year-old park is missing surface protection. We recommend that the operator consult the owner's manual and the structure is not to be used until it's properly installed.</li> <li>•All structures are closed for the winter. There is a fence around each play structure. In the spring we recommend that the centre use their owner's manual to ensure that all play structures are properly installed according to their manual.</li> </ul> <ul style="list-style-type: none"> <li>•Facility meets regulations required under the Early Childhood Services Act.</li> <li>•Recommending licensing for another year.</li> </ul>
