<p>General Comments</p> <p>Catherine was reading to the two children present when I arrived. Catherine talked about the pictures, asked questions and responded to children as she read. The children have shown an interest in gingerbread after some books and discussions about the difference in girl and boy gingerbread. Catherine is continuing their interest with different activities and a selection of gingerbread books from the library.</p> <p>Catherine has her book corner set up to welcome time cuddled up with a book. She has light curtains surrounding the area with mini lights hanging from ceiling and a number of pillows to sit on. The books sit in the corner with a shelf up higher with more books.</p> <p>Catherine regularly took notes and pictures of the children as they engaged in play. Evidence of documentation was posted around the room; art pieces, letters from children, crafts and photographs.</p> <p>After snack and some free play, the children got ready to go outside, The children's food from home today included cookies, suckers and crackers without any vegetables or fruit. Ideas for healthy snacks are included in Appendix 28 of the manual and could possibly be a good resource for parents in preparation of snacks and lunches.</p>
