Comments: This is a follow up visit and licensing staff observed that the play space is cluttered and untidy. This was a concern addressed during a monitoring visit in the summer. The indoor play area must be maintained clean and safe, free of clutter and excess of materials and equipment. The operator must include the following in their general housekeeping duties. that is to vacuum floors daily, clean regularly the kitchenette and bathroom and sanitize toys, equipment, furnishings throughout the day. Please add this to your cleaning checklist and email a copy for the licensing staff's review.			

<p><b>General Comments</b></p> <p>Monitoring inspection performed.</p> <p>Upon arrival, the operator stated, 'I have two children today and one is napping. I have a few out sick, parents kept them home'. The preschool child was interested in pom poms and was separating them into different piles in different colors. The operator was observed sitting at the child's level asking the child different questions. After washing their hands, they moved into a cooking activity - more specifically making cinnamon and apple sauce xmas ornaments. The operator gave the child lots of opportunity to participate and provided instructions that were easy for the child to understand. Lovely positive interaction observed.</p> <p>Administrative records were reviewed - child and operator's attendance is tracked, fire drills and outdoor maintenance check list completed as per required.</p> <p>As per the compliance above - the Operator created a cleaning checklist, but licensing staff is asking the operator to add more checklist items, that is there is an excess of toys, equipment and materials and the play space needs to be downsized and items stored.</p>
