## General Comments

A Monitoring Inspection was completed today. Educators, in each of the different classrooms, were observed talking to, listening, and taking part in activities with their children. Several forms of documentation were observed throughout the facility.

Infant Room - Infants were sitting on the floor, looking at books, and playing with toy vehicles and balls at my arrival. An educator was observed sitting with two children in the reading corner, looking at books. Infants were observed washing their hands before lunch. Infants were served chicken fried rice.

Tot's Room - Children were observed during their lunch. The children sat at their table, and they were severed Chicken Fried Rice. After lunch, children were observed playing with their blocks, Mr. Potato Head, and looking at books.

Two's Room - Children were observed washing their hands before snack. Children were observed sitting at their table, eating a blueberry muffin and berries.

## **General Comments**

Three's Room - A group of children were observed sitting in the reading corner, listening to their educator read a story. Others were observed playing with baby dolls and Barbies, while others sat at a table, with another educator, coloring.

Pre-K Room - Children were observed in the gym and in their classroom. While in the gym, children were observed playing with a parachute. While in the classroom, children danced to music, built habitats with loose parts, and played in the Dramatic Play Area, selling Lemonade, to their Quality Assurance Monitor.
