Comments: The floors within the TV room were unclean and in need of thorough disinfection.

Comments: The environment within the "Games room" is in need of additional creative art materials. Junior adventure camp was also in need of creative art supplies, especially glue (there was no glue today and the children were requesting this). Ensure that art supplies are being replenished as needed.

Comments: The shelving unit in the quiet center within the TV room was unclean. The foosball table within the TV room is also collecting dust/debris-to be cleaned. The building center within the multi-purpose room, containing the wooden track pieces was collecting debris/dust and in need of cleaning.

Observed cleaning and sanitizing of toys today throughout the facility. Children were engaged in

activities/sports/games and creative art. Observed cleaning checklists posted within the rooms. Ensure relief staff are relieving the same room consistently as much as possible. If an educator is covering multiple rooms, or if they are typically at the front desk and step in to relieve an educator at another time, it is recommended that they wear a face mask and be treated as a visitor within that room.
