General Comments

Upon Licensing staff arrival, all rooms were having a snack. Educators were observed sitting with the children and offered gentle reminders to eat. After snack, the 4-year-old room had circle time with a story and the Jr. 4's room had circle time sharing Thanksgiving meal ideas and what they are thankful for. In the Jr. 4's room, Educators sat on the floor with the children and shared what they are thankful for and then used the green painted talking rock to take turns saying what starts with the letter B. Educators were engaged with the children encourage the children to build a pretend beaver hut with wooden blocks. Kind words of encouragement and praise such as "good job!" "you are right!" and "that is perfect" were heard.

After snack, the 2/3-year-old room was preparing for a field trip to the apple orchard. The bus was running a little bit late, and Educators were observed putting out crayons and letters to colour, sensory play toys and read a spooky Wheels on the Bus story to help pass the time. Once the bus arrived, the transition was smooth.

General Comments

When the children returned from their field trip, a picnic style lunch was served before nap time. The transition between lunch and nap time was calm. Soft music was played and the children went to sleep quickly.

The 4-year-old room and the Jr. 4's went outdoors to play after morning circle time. The outdoor play space had a large shaded sandbox, a wooden play structure with plastic pipe slides and tunnel, a climbing structure, a swing, wooden playhouses and toys. Children were observed pretending to bake pies in the mud kitchen and using dump trucks as pie plates. Educators maintained clear lines of site and were actively engaged with the children. After playing outdoors, the children came in to have lunch. Children were observed washing their hands and getting their water bottles ready at their tables. For lunch, the children had pizza pasta casserole, green beans and apples. Educators sat with the children in all rooms while eating and helped the children clean up their dishes. After lunch, the children in the 4-year-old room were observed playing in centers and the Jr. 4-year-old room was resting with an audio book about Thanksgiving.

The classrooms for each age group were clean and tidy. Play material in each room was in good condition and organized in bins or baskets with labels and pictures. In each room, there were wooden blocks, family photos, books, cozy corners with books, play kitchens, art supplies as well as elements of nature such as large pieces of tree bark, hanging plants and branches. The hallways and classrooms were welcoming with children's artwork and learning stories on display. The classroom doors were decorated with pumpkins painted by the children and a colourful Happy Fall display. The children's belongings were organized and hanging up on hooks with their names and water bottles were always accessible. The main parent board contained all required documentation and each classroom had routines and allergies posted.

Staff files were in order and contained required documentation.
