- During the winter months, outdoor play space must be kept accessible; stairs, walkways, ramps, porches, parking areas and driveways must be kept free from accumulations of water, ice and snow; gates and exists must be kept clean of snow and ice and open and close with ease. After a discussion with the fire Marshall, the snow that is up against the fence and the entryway into the outdoor play area must be removed.

- The daily activities are purposely planned and documented and responds to the needs and interest of each child. In all rooms evidence of purposeful planning based on children's interest and learning, invitation, photos and learning stories were posted.
- Observations:

2-3-year-olds:

The children played outside. The children came in washed their hands and had lunch.

3-4-year-olds:

The children participated in a letter recognition activity with the educator. The educator mentioned that the children are showing an interest in letters lately. The children played with balloons and then went outside to play. Parent arrival was also witnessed. The children are working on an ongoing science project. They are growing mini pumpkins.

- Discussion with the administrator on hot beverages, outdoor play area, professional development hours and Public Health. In the indoor play area, I recommend that more play material be added to the zones.
