<ul style="list-style-type: none"> - Visit done at the facility in the morning for a monitoring inspection. - Ratio was maintained during the visit. - During the visit the facility used positive child guidance. - The parent board at the entrance of the facility has all required documents posted. - Monthly emergency evacuation and fire drills are completed. - There is no stationary equipment in the outdoor playground. - A daily incident log is maintained. Parent is advised of incidents and signs the daily log. - The facility has the proper number of functioning and available toilets and sinks. Children are always supervised when using the washroom. A training seat is provided. Steps or platforms are provided to allow children to reach toilets or sinks. - Each child has its own individual space to put their belongings. - Personal belongings are labelled with the child's name, easily accessible and stored separately for each child. - The summer student that is not 19 years old cannot be alone with a group of children, open or close the facility. - Observations: Parent arrival <p>Preschool: 2–5-year-olds: During the visit the children were outdoors.</p> <p>After schooler's: The children and the educator were gone to Riverside parc on an excursion. The children arrived from their outing washed their hands and ate their lunch.</p> <ul style="list-style-type: none"> - Discussion with the director on the outdoor play area, activities taken place off the premises and consent forms.
