During the renewal inspection, inspector observed children playing outside in the snow and also observed children playing indoor with a water table and listening to music. Inspector observed snack time as well.

Inspector recommends that the weekly menu be posted near the school aged children's classrooms.

Ratio was respected during the time of the inspection.

Administrator must ensure that all members of the Board of Directors have a criminal record check or vulnerable sector check. A record of suitability with the Department of Social Development is also required if they have contact with children or responsible for finances as part of their role. The vulnerable sector check must be completed for those people that have contact with children at the facility. Administrator must ensure that all required checks are on-site when the inspector presents themselves during the follow-up inspection.
