General Comments

Licensing staff was properly screened in for Covid-19 upon arrival at the centre. The Administrator signed her in and gave her the current Covid-19 questionnaire to fill out.

The first classroom that Licensing staff made observations in was the infant room (0 to 15 months). The children had just finished eating their snack and the educator was preparing their purposely planned activities for the morning. The first activity that the children engaged in was an exploration of different colours of pieces of paper cut into different shapes. The educator strategically sprinkled the shapes over the children's heads which then fell to the ground. The children immediately went to touch the pieces of paper to explore the properties of the coloured shapes. The children extended the learning experience by taking a child size broom to gather the pieces of paper into a pile and explored the pieces of paper again with their fingers.

The next activity that the infants engaged in was a painting activity. The children sat in their highchairs to explore the properties of paint drizzled on a piece of paper. The educator gave the children numerous tools to explore the paint with. These tools included: small and large paint brushes along with different shaped sponges. When the children were given little bowls of soapy water to wash their hands, the children decided to

explore adding bubbles to their paintings!

The second classroom that licensing staff observed in, was the second infant classroom. The children were searching for a spider that was outside when they stepped onto the playground. They searched and searched but could not find where he crawled away to so the children began looking for other bugs while another children ventured outside the fenced in area with a one of their educators to collect items for a craft activity. The children collected their items in a paper bag and when they were finished collecting, the group went back into the fenced in area and sat down at the picnic table to place their collected items onto a piece of "mactac." The children enjoyed this activity!

The next classroom that licensing observed in was the third infant classroom. The children in this classroom were also outside. A group of children were engaged with the water table using spatulas and large spoons to splash the water while another group of children were mark marking on the pavement with sidewalk chalk. The educators were observed engaging with the children at the child's level and lots og giggles and laughing was heard.

When licensing staff observed the 2 year old groups, the children were engaged in a dance party. The educators and the children were all singing and dancing! After the dance party, the children and educators began to play "ring-around-the rosie."

All of the educators were very interactive and engaged with the children at all times during the inspection visit.

During the inspection visit, licensing staff observed a diluted solution of Lysol and water that was not stored in a locked cabinet or in a closet. Even though the cleaning product was out of reach of children, all cleaning supplies need to be stored in a locked cabinet or closet. When this was brought to the attention of the Administrator, the products were immediately removed from the classrooms and were placed in a locked closet..

During the inspection visit, it was noted that a number of the children's lunch bags, as well as, infant bottles and water bottles were not labeled with the appropriate child's name and when this was brought to the educator's attention, the educators labeled the bottles and lunch bags before licensing staff left the centre.
