### General Comments

Infants and toddlers were participating in a variety of activities during the morning of the monitoring inspection. Educators were actively engaged with children on their level and were observed using positive child guidance techniques such as kind reminders, encouragement, praise, and time for transitions.

The junior nursery room had some new toys added and the infants were enjoying them. The educator has purposely kept the large window accessible for the infants to look out at the snow and outdoor play space. The room was calming and well-suited to the needs of 0–14-month-olds.

The senior nursery rooms both have areas designed to allow more gross motor play as the infants in these rooms are 15-24 months. There are foam climb and crawl activity sets and cozy reading areas. I observed both of these groups returning from outdoors and preparing for lunch. These transitions were smooth, and educators sat with the infants during lunch. I observed one educator using baby sign language and another educator kindly reminding an infant to stay seated in their chair. They assisted the infants with positioning their food in front of them and were nearby to help but also encouraged lots of independence with utensils and self-feeding.

One of the two's classrooms was exploring colors during the morning. The educator had popsicle sticks and pom poms included in different invitations. The children were also very interested in cars and trucks. The educator was very patient with a child who was potty training.

The second two's room had boxes in the classroom for the children to use in their imaginative play. There are well-defined areas in the room for pretend play. The educator said the children love playing with the baby dolls and she has included bottles, carriers and change mats to expand on this play. Before lunch the children sang and danced to songs and participated in doing the actions along with their educators. Children had turns choosing which song was next.

All washrooms were clean and stocked with all required supplies. Diapering areas were also clean and met all regulations.
