<p>General Comments</p> <p>Completed renewal inspection today (delayed due to COVID-19). Children were observed to be engaged in indoor and outdoor play. Imaginative play was observed outside which was initiated by a child and encouraged by the operator. The children were very respectful of one another and their educator. The children demonstrated an appreciation and interest in books and singing songs. Nurturing interactions observed between the operator and children throughout the inspection. The children were very familiar with their daily routine and appeared very comfortable within their environment. Recommend storing nap mats within bags if they continue to be stored within cupboard unit in rest area to ensure that there is no contact between the children's bedding. If a napping child is not directly supervised, a documented physical check of the child must occur every 15 minutes (see page 54 of Operator Manual for Early Learning and Childcare Home for more information). Recommend placing a copy of Extreme Allergy Management Plan in the bag with child's Epipen. Ensure that this emergency plan is reviewed with the parent and signed annually.
