## **General Comments**

A Monitoring Inspection occurred on February 18, 2025.

Children were observed during indoor free play and snack. Proper handwashing procedures were followed during snack time. Steps or platforms were available to ensure children could independently reach regular-sized toilets and sinks.

Operator shared that children are currently very interested in cars and movement-based activities. To support these interests, they have created an indoor roadway for biking, encouraged climbing on a climber, facilitated active outdoor play, provided opportunities for painting on snow, and engaged children in Valentine's Day celebrations with cards. Throughout the inspection, operator was observed using positive language and offering gentle reminders to support children's interactions and transitions.

The daily incident log is maintained, and parents are informed of any incidents. Parents of enrolled children are granted entry to the center at any time. Outdoor play occurs for at least one hour within every four-hour block of time when the majority of children are in attendance, weather permitting. Monthly emergency evacuation drills are conducted.

A clearly visible and prominent space is designated for posting the facility's license, current inspection report, monitoring reports, and any orders for compliance. Rest periods are individualized and do not exceed two consecutive hours. Nap equipment meets the required minimum thickness of 5 cm. Snacks are provided at intervals of no more than three hours, and meals are scheduled at recognized meal periods.

The room is thoughtfully arranged to be inviting, with materials intentionally set up to encourage play. Books have been carefully selected to reflect children's interests. The facility maintains a varied supply of age-appropriate equipment, materials, books, and toys.

Traffic areas are kept clean, and outdoor walkways remain free of clutter. Toxic products, including chemical cleaners, are securely locked and inaccessible to children. The diaper-changing area is located within one meter of a sink, and diaper-changing procedures are posted and clearly visible to those completing diaper
